#### Message from the Director General

Dear Members,

India is transforming at a rapid pace. As per latest Press Release of RBI, India's GDP growth is really strong. This can be linked to decline in inflation rate as well as in commodity prices. GDP growth, however, is a measure of overall performance. Two sectors agriculture/rural and listed corporate have seen slower growth in the recent past. According to the Economic Survey presented in the Parliament on February 26, 2016, agriculture which is still principal means of livelihood in India, grew at a rate (-) 0.2% in 2014-15. Also, manufacturing capacity utilization, which is expected to provide more jobs on the back of the 'Make in India' push has been low at 70%. Under such a backdrop, performance of the economy becomes more complex to assess. Let us hope that better implementation of good regulatory measures makes domestic economic performance more stable and broad based in coming years.

The Economic Survey also reveals that as per the information of the Department of Agriculture, Cooperation and Farmers Welfare for 2015-16, the production of food grains and oil-seeds is estimated to decline by 0.5 per cent and 4.1 per cent respectively, while the production of fruits and vegetables is likely to increase marginally. This implies need to focus on agriculture. Given this, Bombay Chamber recently conducted a seminar in Pune on "Entrepreneurial Opportunities in Agro & Food Processing Sector for Inclusive Market Oriented Development".

The Goods and Services Tax is the biggest indirect tax reform since 1947. The vision for GST also involves a digitized administration, Chamber is organizing a seminar on "Gearing Up for GST" for the benefit of its members in the month of May. In addition to functional aspects, the event will also provide deeper insights into the IT strategy adopted by the GSTN.

E-waste is a relatively new term, with impetus provided by the boom in Information Technology (IT). The Chamber is holding an event on E-waste Management which will focus on the "beyond compliance" scenario. The event will also highlight simple yet effective ways to manage and handle waste at individual and corporate levels.
